## GLASS BREAKAGE NO FAULT LIFETIME GLASS BREAKAGE NON-PRORATED TRANSFERABLE LIMITED WARRANTY

Lifetime glass breakage coverage for the original purchase/property owner and 20 years for the succeeding owner. Kensington HPP, Inc., manufacturer of Kensington Quantum2 Vinyl replacement windows, makes available to the original purchaser or present property owner the Lifetime Non-Prorated Transferable Limited Warranty, warranting against glass breakage for as long as the property owners (single family, owner occupied) shall own or reside in the home in which the products were installed from the date of window installation.

If glass breakage does occur within the time period specified according to the provisions of the Warranty, then Kensington HPP, Inc. agrees to provide the replacement glass free of charge, F.O.B. Dealer.

This Warranty is valid only so long as the windows are installed on the premises of the original installation. Removal of the windows invalidates this Warranty. As described above, this Warranty is limited to the material cost of the glass and does not extend to labor costs. Kensington HPP, Inc. will not be responsible for any costs incurred in the removal or reinstallation of the glass furnished by manufacturer under this Warranty. This Warranty does not cover acts of God such as Hurricanes, Floods, Earthquakes, etc. For further information, please contact our office.

## **CLAIMS PROCEDURE**

Submit Warranty claim in writing by certified mail to the appropriate Kensington Quantum2 Dealer. The Claim Notice must state the date of installation, the date and number of this Certificate and include Proof of Purchase. This warranty shall be for the benefit of the original purchaser/property owner, and shall be transferable. Upon transferal the Warranty will convert to a 20 year non-prorated limited warranty from the original date of purchase. When the warranty is transferred, the new property owner submits the original Warranty, along with a statement of his or her name and address of the property to the appropriate Kensington Quantum2 Dealer within fifteen (15) days after becoming the succeeding property owner. It is limited to the manufacturer furnishing new glass, free of charge, F.O.B. Dealer. In the event of such replacement, the remaining portion of the original warranty period shall continue in effect and cover the replaced glass.



This Warranty is valid in those states where permitted. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. You should check the local state laws to determine this. This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

THE DEALER IS NOT AUTHORIZED TO OBLIGATE Kensington HPP, EXCEPT STRICTLY IN ACCORDANCE WITH THE TERMS AND CONDITIONS OF THIS CERTIFICATE.
